Scope of the audit / review including sites visited	Forest management operations in plantation forest management units in Tasmania. Management by staff of Reliance Forest Fibre Pty Ltd. Offices and forests, as listed above. Contact with stakeholders. Follow up open findings & collect information for Responsible Wood's PEFC reporting.		
Global-Mark summary of the main findings	Changes since the recertification audit in June 2022 include the staffing and resourcing of its operations and system. Management of forest activity at RFF is now 100% in-house with no services from AKS Forest Management Services as of 30 June 2022.		
	This audit also identified that there are changes needed to the sites included in the scope of certification of Reliance Forest Fibre. Firstly, the office moved premises in late 2022. Secondly, there is an office for the two members of staff in the southern region, which is at St John's Park in Hobart, and this needs to be added.		
	A subset of the performance requirements of the nine core criteria of the standard were assessed. The audit duration of four [4] auditor days, undertaken by a team of three, comprised 75% field inspections across Tasmania, including the southern region, as well as the core areas in the Tamar basin region.  The audit team leader made contact by phone, during the audit, with one stakeholder affected by machine noise from operations. This matter is still being communicated between the stakeholder and RFF.		
	Noteworthy positive comments:		
	1. Fire preparedness - a good level of resourcing by contractor BR & KF Muskett at coupe SX051w.		
	Fire risk management - staff member Mitch applying his competence in use of moisture sticks in a plantation reafforestation setting to aid decision making for debris burning.		
	3. Biodiversity awareness - site preparation owner/operator contractor B & A Hodgetts at coupe had their own video of quoll at night climbing a tree, so displayed interest and ability to identify priority species.
